



## Joining condition for Groups

### Joining conditions for all people who sign up for Flamboree 2009

Flamboree 2009 takes place on the Hopper youth site "de Kluis" in Sint-Joris-Weert, near Leuven in Belgium, from Wednesday the 29th of July 2009 until Saturday the 8th of August. flamboree is organised by Scouts en Gidsen Vlaanderen VZW.

1. All people, born between the first of January 1991 and the 29<sup>th</sup> of July 1995, who are member of a scouting organization recognized by WOSM or WAGGGS, can join the Flamboree. Exceptions for this age limit can be permitted after a written demand and with well founded reasoning. All people born before the first of January 1991 can join the Flamboree as a leader. The organization schedules a minimum ratio leader/members of 1 to 9.
2. Subscription is done per age group by the online registration form. Each group has one contact man, who represents the whole group. This contact man passes all of the received information on to the group. He/she is responsible for the accuracy of the data on the subscription forms. The contact man should provide a valid e-mail address since all communication from the organization to the groups happens mainly by e-mail. Postal correspondence is still possible.
3. The organization should have received your registration before the 28<sup>th</sup> of February 2009. If the maximum number of participants (1.200) is reached, a waiting list will be installed.
4. The costs for joining when subscribing before the 30<sup>th</sup> of November 2008 amount to €210 per person for members as well as for leaders. An advance of €70 should be paid, at the latest 4 weeks after receiving the advance invoice. All possible extra bank fees are to be paid by the participant. Subscription is only definitive after receiving this advance and after a written assurance from the federation given up by the contact man that everyone of the group is indeed a member. The contact person will receive an invoice for the remaining subscription fee only after the 15<sup>th</sup> of January. This should be paid in the four weeks following the receipt.
5. Subscription after the 30<sup>th</sup> of November 2008 is also possible, the costs will be raised by €10. All of the subscription fee of €210 should be paid in the 4 weeks after the receiving of the invoice. Subscription will only be definitive after receiving this fee and after a written assurance from the participants' federation that all of them are indeed a member.
6. If the fee isn't paid before the limit mentioned above, the subscription will be canceled in disadvantage of the participant(s) after a written warning. All already executed payments remain the property of Scouts en Gidsen Vlaanderen VZW.
7. Subscription fee includes: all meals from dinner on the 29<sup>th</sup> of July to lunch on the 8<sup>th</sup> of August 2009, the entire program offer (transport to and from activities on location included), use of the camping site and sanitary fittings. Transport to and from the camping site and additional drinks and snacks are not included.
8. In case of cancellation before the first of March 2009, the advance will be paid back entirely, except for a €25 cost (and all possible bank fees). While canceling after the first of March and before the 31<sup>st</sup> of May, at maximum half of the fee will be repaid (except for all possible risen bank fees). In case of cancellation after the 31<sup>st</sup> of May, repayment won't be possible.



9. In case of circumstances beyond one's control, a subscription can be cancelled exceptionally, with conclusive evidence. The subscription fee will be repaid, except for the costs already made by the organization (a minimum of €25) and the possible bank fees that may arise. This cancellation should be reported to the organization as soon as possible, within a week of the rise of these circumstances and at the latest before the actual start of the Flamboree. This cancellation must be done by written medium (e.g. e-mail, fax, letter) and must contain a clear description of the circumstances and all possible evidence.
10. Until the 31<sup>st</sup> of June 2009 it's possible to name a substitute in case of cancellation of a member of the group. No additional costs have to be made. However, the new participant must also meet the general requirements.
11. A rise of the participants' number will be costless until the 28<sup>th</sup> of February. After this date, a rise can be permitted, but the subscription fee for the additional member(s) will then amount to €230.
12. By arrival on the camp site, the number and personal data supplied at subscription will be checked once more by the organization.
13. Participants who are member of Scouts en Gidsen Vlaanderen are already insured by having paid the member's fee. This insurance remains during the Flamboree. Participants who aren't a member should have an insurance securing against personal physical accidents, repatriation and civil liability. A proof of this insurance should be provided to Flamboree's organization. In some cases, an insurance from the organization of Flamboree itself is possible.
14. The participant is responsible for his/her personal equipment and group equipment. The organization declines every responsibility for loss, theft or damage of participants' equipment during Flamboree or the journey.
15. The organization cannot be held responsible for personal accidents taking place during the camp. Furthermore, the organization cannot be held responsible for circumstances beyond its control resulting in the (partial) cancellation of the camp. In that case, no part of the subscription fee will be repaid, except when decided otherwise by the organization of Flamboree.
16. While paying the (advance and) subscription fee, the participants formally agree with the conditions for joining as stated above. The behavior rules will be added to this conditions and delivered to the participating group after registration.
17. In case of juridical problems, only the Belgian law applies; the courts of justice of the district of Antwerp will be competent. The organization of Flamboree reserves the right to dissociate from this clause assigning juridical authority.
